## **Communications & Power Industries Awarded \$3.5 Million for Airborne Data Links and Ground Data Terminals**

**PALO ALTO, Calif. - May 4, 2015** - The Malibu Division of Communications & Power Industries LLC (CPI) has been awarded a production contract totaling more than \$3.5 million to supply advanced antenna products, including dual-axis Ku-band ground and airborne data links, for a mid-altitude long endurance (MALE) unmanned aerial vehicle (UAV) platform. Combining the high-precision auto-tracking capabilities of CPI Malibu Division's ground data terminals with its airborne advanced data link antennas provides warfighters with a quickly and easily deployable solution for greater situational awareness in the field. CPI Malibu Division currently provides ground and airborne data terminals for a number of UAV platforms worldwide.
